2020 INTERNATIONAL FESTIVAL CULTURAL DISPLAY CONTRACT

The following signifies a contract between the cultural display group and the event coordinators.
The following set of guidelines has been drawn up so that all participating cultural groups are
equally represented at the festival.

APPLICATION DEADLINE: DEC. 18, 2019

- In order for any student group to sign up, they **MUST** be registered in Engage as an official Florida Tech organization.
- Groups wishing to set up a cultural display at the 2020 International Festival must register by Wednesday, Dec. 18, 2019.
- All cultural display groups must arrive no later than 10 a.m. to ensure that displays are set up and ready to go by 11:30 a.m. You may arrive earlier than this if you wish.
- All cultural display groups must notify the event coordinators at least one week prior to the event if they no longer wish to have a cultural display booth at the festival.
- All cultural display groups must keep their noise levels to a minimum in order to ensure that there are no distractions/interruptions to the stage performances.

We, the _____ group participating in the Florida Tech 2020 International Festival, agree to comply with all of the above requirements as outlined by the cultural display committee. We understand that failure to comply with any of the above requirements may result in our group's disqualification from the event.
